Gregory Mankiw in his Principles of Economics outlines Ten Principles of Economics that we will replicate here, they are: People face trade-offs. Ten principles. Of economics. The word economy comes from the Greek word for "one who manages a house-hold." At first, this origin might seem peculiar. But, in fact, households and economies have much in common. A household faces many decisions. It must decide which members of the household do which tasks and what each member gets in return: Who cooks dinner? Who does the laundry? Who gets the extra dessert at dinner? To get one thing that we like we usually have to give up another thing that we also like. Making decisions requires trading off one goal against another. When people are grouped into societies, they face different kinds of trade-offs. One trade-off society faces is between efficiency and equity. Efficiency means that society is getting the most it can from its scarce resources. Equity means that the benefits of those resources are distributed fairly among society's members. Life's trade-offs is important
